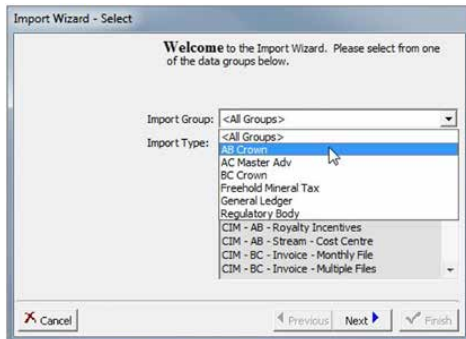

These additional RMS capabilities may be activated as organizations scale in size and complexity:

- **Allowable Cost Master** provides an accurate and efficient method for managing Allowable Cost filing (capital and operating expenses).
 - Changes (ownership or costs) can be entered as they occur, or at the end of the year
 - Appropriate carry forward information is created automatically, based on prior year data
- **Crown Invoice Manager** manages Crown royalty invoices. The system processes invoices and generates financial vouchers and reports for Alberta, Saskatchewan and British Columbia.
- **Freehold Mineral Tax Module** provides the ability to import the Payor, Owner, and Lessee tax statements; generate reports; create vouchers; and calculate a Gas Unit value based on the information available from the AB Crown Invoice files.
